

# The Power to Dream

## OFFICIAL SWEEPSTAKES RULES

**NO PURCHASE, OBLIGATION OR TRANSACTION NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

### 1. HOW TO ENTER

a. The Power to Dream Sweepstakes ("Sweepstakes") will begin on Saturday, Mar. 1, 2008 at 12:01am Pacific Time (PT) and end on Saturday, May 31 at 11:59pm PT ("Sweepstakes Dates").

b. To participate in the contest:

1) Visit any branch of WPCCU in Southern California (a complete list of all participating locations and addresses can be found on [www.KNX1070.com](http://www.KNX1070.com)), during the Sweepstakes Dates during regular business hours, and fill out an official Sweepstakes entry form, while supplies last. Fill out the entry form with your first and last name, complete address including city, state, and zip code, telephone number, email address, and date of birth and deposit it in the official entry box on location. No alternate entry forms will be accepted. No photocopies will be accepted.

2) All members of WPCCU who fund their first or second trust deed loan, fixed or ARM, or home equity loan through WPCCU during the Sweepstakes Dates will automatically receive one (1) entry into the Sweepstakes. One entry per person.

3) Hand print the words "Power to Dream Sweepstakes" and your full name, address, daytime phone number, and date on a 3x5 card and mail it in a sealed envelope to: WPCCU, Power to Dream Sweepstakes, 1053 W. Sunset Blvd., Los Angeles, CA 90012-2134. Mail entries must be postmarked by May 31, 2008 to be eligible.

4) On the Internet, go to [www.wpcu.org](http://www.wpcu.org) during the Sweepstakes Dates and complete the "Power to Dream Sweepstakes" entry form. You must include your full name, address, daytime phone number, email contact information and the date that you completed the form. Internet entries must be received by June 3, 2008 to be eligible.

All entries become the property of WPCCU and KNX and none will be returned. WPCCU and KNX are not responsible for lost, misdirected, delayed, destroyed, deleted, erased, stolen, unreadable or mutilated mail. Mechanically reproduced entries will not be accepted. Alternate mailed entries are limited to one per person. If more than one entry per person is received this will disqualify all entries by that entrant.

### 2. ELIGIBILITY RESTRICTIONS

a. The Sweepstakes is open to all persons who are 18 years of age or older and reside in Los Angeles County, Orange County, Riverside County, San Bernardino County, Ventura County and San Diego County. Employees, volunteers and consultants of the WPCCU and its subsidiaries, and their family members within the same household are not eligible to win. Employees of KNX 1070, its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Los Angeles/Orange County metropolitan area and the members of their immediate families and/or households of the same mailing address, are ineligible to participate or win.

If the selected winner is from an entry by ineligible persons or an entry which was made as the result of an error that selected winner will be disqualified and an alternate entry selected

- b. Any person or persons in your immediate household or family may qualify or win a KNX contest only once every (90) days and a prize valued at \$600 or more only once every six months. Only one winner per household is permitted in any KNX contest.
- c. Winners must hold a valid California driver's license or valid government issued photo identification and must sign all required releases in order to accept the prize.
- d. In order to be eligible to accept the prize, the winner must be the owner of the property where the prize will be delivered and installed. Winner must be able to display proof of ownership of the property.
- e. Contestants are required to provide truthful information and KNX 1070 will reject and delete any entry that it discovers to be false or fraudulent. KNX 1070 will also disqualify and delete any entry received from persons under the minimum age requirement specified for this contest and will also delete the entries received from any person under the age of 13 in compliance with the Children's Online Privacy Protection Act.

### 3. PRIZES

- a. One grand prize will be awarded. The grand prize is one (1) "Power to Dream" custom designed Garden Room Patio valued up to \$18,600, provided by Southern California Rooms (SCR). Grand prize includes floor to ceiling installation, materials and labor, including the installation of a concrete slab to be provided by WPCCU. Slab is valued at \$1,600.00 Installation must be completed in full by May 31, 2009. The grand prize has no cash value. Any additional costs incurred are the responsibility of the winner. The Approximate Retail Value ("ARV") of the prize package is = \$18,600.00.
- b. The awarding of the grand prize will be handled by Southern California Rooms and KNX 1070. The grand prize is non-transferable and no substitution of the grand prize is permitted. KNX 1070 will report all prize winnings to the appropriate state and federal agencies as required by applicable law. Payment of any federal state or local taxes will be the obligation of the winner. Any costs not specifically identified herein are the responsibility of the grand prize winner.
- c. WPCCU and KNX 1070 are not responsible for any damage incurred to the winner's property during the installation of the appliances and/or products.
- d. The winner is solely responsible for obtaining all necessary permits, inspections and licenses as required by applicable law as well as the associated costs to obtain all permits, inspections and licenses.
- e. Winner's property conditions shall be evaluated and installation requirement determined by Southern California Rooms (SCR). In the event that the prize winner is unable to have the grand prize installed on his/her property, as determined solely by Southern California Rooms and KNX 1070, the winner will forfeit his/her prize and WPCCU, Southern California Rooms and KNX 1070 will have no further obligation to the grand prize winner.
- f. There is no substitution, transfer, or cash equivalent for prizes, except that Southern California Rooms and KNX may, at their sole discretion, substitute prize elements of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of WPCCU, Southern California Rooms and KNX 1070 management with respect to the sweepstakes are final.

- b. On or about June 16, 2008 at approximately 11am PT, one (1) winner will be randomly selected from all eligible entries received by the respective entry deadlines. Winner will be selected off-air.
- c. The odds of winning depend upon the number of eligible entries received by the entry deadline.
- d. The grand prize winner will be notified by KNX 1070 by e-mail and telephone within five business days of selection. The winner will be required to sign an affidavit of eligibility and a liability/publicity release, which must be returned within 15 days of notification. If the winner cannot be contacted within two weeks of selection, an alternate winner will be selected at random.
- e. In the event that the grand prize is forfeited as described in Section 3c., KNX 1070, at its sole discretion, will select an alternate winner from all remaining eligible entries.

## 5. CONDITIONS
